Treasurer's Report for the April 2022 Board Meeting

March 2022 had receipts considerably lower than in the prior month (\$2,394.05 compared to the \$7,300.00, that was received in February). Fortunately, expenses were also less than in February (by about \$500), which, unfortunately, was not enough to avoid a net loss for the month of March of (\$544.56). Net income for this fiscal year-to-date remains very positive at \$25,456.81.

As of March 31, 2022, we had \$4,858.04 available in checking. We also have a total of \$19,105.48 in all savings accounts, including \$2,545.00 in the Ronda Decaire Memorial Fund. I still haven't made any adjustment, but, as reported last month, the total market value of our investment in UUCEF funds has declined from \$81,847.52 to \$77,296.88, a market value decline of \$4,550.64 (5.6%).
