- I. Call to Order 1241 PM. Present were Jana (by phone), Carole, Cristin, Jack, and Marilyn. Also present were Marla, Jim, Doug, and Daniel Polk.
- II. Consideration of June Minutes as distributed Amy had a correction, Jack didn't get it but it will be sent asap, otherwise accepted.
- III. Finance report Carole see attachment Point Pledges are lower by 9k. We lost Paula, her pledge and the free yard maintenance. We will have to cover this by taking money from savings. This is a long-term issue. We have an older congregation, an older building we have to consider that we will need to pull from savings in the next few years.
 - A. Operations- Marilee was generous last fiscal year & added 19k in June but we need to be fiscally responsible with this and think long term. Goals—repairs, marketing plan for growth, some renovations.
 - B. Carole moved to restrict the 19k to repairs & renovations & increase our visibility in order to grow our congregation rather than adding it to the general fund; Jim suggested discussion and voting on each category-- music today was great give some money to Worship Team to get more musicians; board will pay for advertising. Unanimous vote to add \$800 to Worship Team budget.
 - C. Advertising—board will ask NTUUC to host a social media workshop. [Daniel Polk was present.]

IV. Doug

- A. Questions what duties the Board pays him to perform; Jana sent Doug the 2022 list of his responsibilities with the tasks he no longer performs removed. No new duties have been added.
 - 1. Weekly programs Worship Team sends outline, he gets graphics & prints it he is paid \$25/week. No change in duties or compensation.
 - 2. Monthly newsletter
 - 3. Weekly Update with iContact
 - 4. Has not printed Visitor Forms or New Membership Certificate in a while but would be to do so if asked.
 - 5. No longer manages website

- B. He wants to clarify P&P concerns hiring & that the Board is not following the P&P—Jana read the pertinent issues and explained that they are being followed.
- C. He wants a job title that does not include the word "Consultant"—tabled
- D. He wants to volunteer to do Congregational Meeting packets Jim does a good job but he does a better job of "beautification"
