She now lives in Plano, Texas, with her spouse, the Rev. Patrick Price, minister of Community Unitarian Universalist Church. Jennifer has recently started taking piano lessons for the first time.

The Rev. Dianna Niemann-Harris is an ordained United Church of Christ minister and Associate Chaplain at Texoma Medical Center in Denison. She holds a Bachelor of Social Work degree from The University of Missouri-Columbia and a Master of Divinity from Eden Theological Seminary in Webster Groves, Missouri. Dianna joined the staff of the Alzheimer's Association, Greater Dallas Chapter, in 2005 and is currently Manger of Family Services in Cooke, Fannin and Grayson Counties. She is also a proud member of Red River Unitarian Universalist Church.

Green Team Tips from November

11/04/07 Fill the Dishwasher

Run your dishwasher only with a full load. Save 100 lbs. of carbon dioxide and \$40 per year.

11/11/07 Use Recycled Paper

Make sure your printer paper is 100% post consumer recycled paper. Save 5 lbs. of carbon dioxide per ream of paper.

11/18/07 Adjust Your Thermostat

Move your heater thermostat down two degrees in winter and up two degrees in the summer. Save 2000 lbs of carbon dioxide and \$98 per year.

11/25/07 Check Your Waterheater

Keep your water heater thermostat no higher than 120°F. Save 550 lbs. of carbon dioxide and \$30 per year.

Our Unitarian Universalist Heritage...

Who was Clara Barton? She was the founder of The American Red Cross, and one of those wonderfully active Unitarian and Universalist women who played major historical roles in transforming the social institutions of the United States during the 19th century.

Born on December 25, 1821 in Oxford, Massachusetts, the youngest of five children in a middle-class family, Clara Barton was educated at home, and at age 15, started teaching school. Her most notable antebellum achievement was the establishment of a free public school in Bordentown, N.J. Though she is remembered as the founder of the American Red Cross, her only prewar medical experience came when for 2 years she nursed an invalid brother.

In 1861, Ms. Barton was living in Washington, D.C., working at the U.S. Patent Office. When the 6th Massachusetts Regiment arrived in the city after the Baltimore Riots, she organized a relief program for the soldiers, beginning a lifetime of philanthropy.

When Clara learned that many of the wounded from First Battle of Bull Run had suffered, not from want of attention but from need of medical supplies, she advertised for donations in the Worcester, Massachusetts, Spy and began an independent organization to distribute goods. The relief operation was successful, and the following year U.S. Surgeon General, William A. Hammond granted her a general pass to travel with army ambulances "for the purpose of distributing comforts for the sick and wounded, and nursing them."

For 3 years she followed army operations throughout the Virginia theater and in the Charleston, South Carolina, area. Her work in Fredericksburg, Virginia, hospitals, caring for the casualties from the Battle of the Wilderness, and nursing work at Bermuda Hundred attracted national notice. At this time she formed her only formal Civil War connection with any organization when she served as superintendent of nurses in Major General Benjamin F. Butler's command.

She also expanded her concept of soldier aid, traveling to Camp Parole, Maryland, to organize a program for locating men listed as missing in action. Through interviews with Federals returning from Southern prisons, she was often able to determine the status of some of the missing and notify families.

By the end of the war, Clara Barton had performed most of the services that would later he associated with the American Red Cross, which she founded in 1881. In 1904 she resigned as head of that organization, retiring to her home at Glen Echo, outside Washington, D.C., where she died on 12 April, 1912.

Since many of our members come from Oklahoma, it was suggested during the Social Action Committee meeting of October 21, that we undertake some projects that will benefit the Bryan County area. Marion Hill has reported that the food pantries are experiencing great difficulties with increased need and lowered supply. In response, we have decided to hold an end of year canned food drive during the month of December. This will benefit Loaves and Fishes in Durant. Please bring any shelf stable food items during any Sunday in December. There will be a donation box located by the Social Action bulletin board in the church foyer. The donations will be delivered to the food bank on Dec. 27th. An additional project to aid the Bryan County Youth Center will be scheduled for April of 2008.

It has become an RRUU tradition to give small Christmas gifts to the clients of Day Star, the sheltered workshop program for disabled adults with whom we share our building. We will be posting individual sheets with the name of one client and a gift he or she has requested. You are invited to choose one or more names, purchase, wrap and label the gift with the person's name, and return it to church no later than Sunday, Dec. 16, so the presents can be distributed to the clients the week before Christmas. If several people or families would like to "share" a client, that would be fine, too.

The Alternative Holiday Gift Program information is now available. (See article below.) For those of you who are not familiar with this project, it enables you to make a gift donation to a number of charitable groups instead of receiving more "stuff" that you really don't need nor have room for. These also make great gifts for friends that have everything.

A calendar of Social Action activities for the coming year is now posted on the bulletin board.

Possible proposals for NTAUUS grant requests were discussed, and a committee of Tom Rawson, John Ockels, and Mary Larkin-Baker was charged with considering options and making a recommendation to the Board at the December meeting. At that time, Kathleen will also be presenting a proposal for a joint campus ministry project with the Denton congregation. Safe Congregation Policy

In October, the Board approved a draft of a Safe Congregation Policy for RRUU (see the Board highlights and President's letter in the November newsletter for details). This policy is now available for review on the RRUU website (www.RRUU.org). Members are encouraged to study the document and send comments to Board President Kathleen Campbell at kcampbell@austincollege.edu, to Task Force Chair John Ockels at ockels@mac.com, or to Rev. Jennifer Innis at revjinnis@earthlink.net. Written comments may also be sent to Red River Unitarian Universalist Church at P.O. Box 1806, Denison, TX 75021 or handed to Kathleen, John, or Jennifer at church.

In addition the Board has scheduled three meetings for members who wish to discuss the policy with members of the task force and the Board. These will be on Nov. 28 at 7:30 at Linda Woytasczyk's house (1902 W. Shields in Sherman), on Dec. 5 at 7:00 at Kathleen Campbell's house (1104 S. Travis in Sherman), and on Dec. 9 at the church following the coffee hour. Childcare will be provided for the meeting at the church.

All comments will be considered by the task force and the Board and a final draft will be brought to the board for approval before the finished document is presented to the congregation for adoption.

Thank you in advance for taking the time to study the draft of this policy carefully. Its adoption will be one important step in the Board's efforts to attempt to address more deliberately and systematically the various issues which will arise as our congregation grows.

Letter from the RRUU Board President

October and November were very busy months for our church. We finished off October with the visit of Carole Czujko, the UUA financial consultant who will be working with us as we move toward ownership of our own building. We have not received her formal written report yet; when we do, it will distributed as widely as possible among our members. But we already know some of the work we need to do. At her final session with some of our church leaders (particularly those involved with finances and the new building research), she gave us some good advice on building the membership, participation, and financial commitments we need to support the purchase and occupation of a new building. She pointed out then, as she did in the congregational workshop, that we needed to focus on the membership development portion of our five-year plan. Actions we need to take include everything moving pews to developing written materials for visitors and new members to improving our stewardship campaign. To get the job done, every member of the congregation will be called upon at some time. As someone said during the workshop—there is no "they" who will do all of these tasks, there is only "we."

Although we have already begun working on some of these tasks, December will be a less busy month at the RRUU. I hope that this will be a time during which you can relax a little, attend our special holidays observances, and enjoy being with our RRUU community. We hope to see you at church throughout the season, and encourage you to bring family and friends who may be visiting. Our Festival of Lights service on the Dec. 16th and our Lessons and Carols service on Christmas Eve might be an excellent opportunities to invite friends you think would find RRUU a meaningful part of their lives. We will be participating in the Alternative Christmas Gifts program again this year, collecting food for a Bryan County food bank, and providing gifts to the DayStar residents—consider being part of these opportunities to extend your holiday giving. If you haven't already picked up your copy of *The Better World Shopping Guide*, please do so, and you might want to buy an extra copy or two for Christmas gifts. And be sure to put the all-church holiday party hosted by the Viki Reeder and Roger Gregory-Allen on your calendars—and come prepared for an old-fashioned carol sing.

The winter holidays are a time for both festivity and reflection at RRUU. Enjoy them—and be prepared to get back to work in January.

Minister's Letter

On the Journey

Any day now I expect to hear the good news of a new baby. This is not such a surprise right now - after all, the focus of this month in the Christian world is the coming of the newborn child. As a tradition both originating from and continually inspired by the Christian faith, Unitarian Universalists all over the land are hanging the church with greens, squeezing in pageants and holiday parties, and counting the candles for Christmas Eve services. I, too, plan on enjoying the month with the chance to dream of what it means to welcome a new life right after enduring the darkest night of the year, and to imagine what can begin anew with such a life.

But today, the only child I am waiting for is the one who will be my new niece. Some time in the next week or so, my brother and his wife expect to welcome the birth of their first child. This child will be my parents' first grandchild and my first niece (or nephew, for that matter) from within our original nuclear family. (If gifts of baby clothes could count as currency, then this baby-to-be has a good start on college.)

As I try to summarize one of the many family units that include this child before she is born. I am struck by how hard it is to talk about the groups to which we are most connected, if we have or desire such communities at all. Is family the people we see a few times a year or the people we see every day? How does this include the people we know well or who know us well? All the while realizing that one's biological family and the people who know us best are often not one and the same. In fact, the lack of understanding within what most of our society counts as "family" leaves scars and wins and losses on most of us and helps make this month one of the least wonderful times of the year. Family is not for the faint of heart. May all of us seek the care we need from the sources in our lives that know us best.

One of those sources for me is the Unitarian Universalist church. I have a chance to explore one such source when Patrick and I visit my family in Massachusetts for the New Year. On December 30, I will preach at the Unitarian Universalist Church of Worcester where my brothers and I grew up, where I was

the interim director of religious education, and where I was ordained to the liberal ministry. People in the pews will include my former Sunday school teachers, some of who were on the Board when I was on staff. I confess I am both excited and anxious. I have not led the service there in about 8 years. And much of my family will attend too on this rare occasion to fill a pew and see me in the pulpit. Along with the greetings from long-time members and meeting first time visitors, I may hear something more of who I was way back then and ponder what is or is not the same for me today. Whether our travels take us far from home or keep us close to the heart, may each of us hold our hearts open to receive the news we need to hear as we await a new life among us.
