## On the Journey...

A time of recognition is emerging from the long conversation between religion and science about the nature of human development. This new addition to the liturgical year is called Evolution Sunday. On February 15, John Ockels and Peter Schulze will offer their reflections on this cultural, social, and religious exchange. In the spirit of Evolution Sunday, I and many other Unitarian Universalist ministers are signing on to a letter of support for the separation of science and religion in public education. #### The Clergy Letter - from Unitarian Universalist Clergy

- An Open Letter Concerning Religion and Science

As Unitarian Universalists, we draw from many sources, including "Wisdom from the world's religions which inspires us in our ethical and spiritual life," and "Humanist teachings which counsel us to heed the guidance of reason and the results of science, and warn us against idolatries of the mind and spirit." While most Unitarian Universalists believe that many sacred scriptures convey timeless truths about humans and our relationship to the sacred, we stand in solidarity with our Christian and Jewish brothers and sisters who do not read the Bible literally, as they would a science textbook. We believe that religious truth is of a different order from scientific truth. Its purpose is not to convey scientific information but to transform hearts.

Fundamentalists of various traditions, who perceive the science of evolution to be in conflict with their personal religious beliefs, are seeking to influence public school boards to authorize the teaching of creationism. We see this as a breach in the separation of church and state. Those who believe in a literal interpretation of the Biblical account of creation are free to teach their perspective in their homes, religious institutions and parochial schools. To teach it in the public schools would be to assert a particular religious perspective in an environment which is supposed to be free of such indoctrination.

We the undersigned, Unitarian Universalist clergy, believe that the timeless truths of the Bible and other scriptures may comfortably coexist with the discoveries of modern science. We believe that the theory of evolution is a foundational scientific truth, one that has stood up to rigorous scrutiny and upon which much of human knowledge and achievement rests. To reject this truth or to treat it as "one theory among others" is to deliberately embrace scientific ignorance and transmit such ignorance to our children. We urge school board members to preserve the integrity of the science curriculum by affirming the teaching of the theory of evolution as a core component of human knowledge. We ask that science remain science and that religion remain religion, two very different, but complementary, forms of truth.

## Social Action—"One More Step!"

Our Share the Plate donation for February raised \$184.10 for the Grayson County Women's Crisis Center. This is a service that provides temporary shelter and support for women facing traumatic life experiences.

Our January food drive ended on February 1. We collected a total of 130 lbs. of non-perishable food, which was split between food banks in Grayson and Bryan Counties. We reported this total, as well as \$229.43 in cash collected by our youth to the national Souper Bowl of Caring organization. We were one of 8,383 church groups throughout the U.S. of many faiths who generated \$4,712,793 for local charities on Super Bowl Sunday.

We recently received and completed a survey for NTAUUS designed to detail services that they could provide to assist in furthering social justice activities among UU organizations in North Texas. While RRUU tends to address social issues more than legal and legislative concerns, providing grass roots training sessions for methods, contacts, and resources would be a great help. A copy of the completed questionnaire is posted on the bulletin board.

Our spring Habitat for Humanity project will be held on Saturday morning, March 29 (weather permitting). The house was completed in Denison in time for the owners to spend Christmas in their new home; however, the yard is still in need of some finishing touches. Late March is a great time to plant and a great opportunity for our youth to volunteer. The home is located at 803 N. 8th in Denison. We hope to work with the Grayson County Master Gardeners on this project. Please mark your calendars.

## **Notes from the President**

This month I am reporting on recent actions of the Board and upcoming processes.

As President, I submitted our congregation's "Certification of Membership" to the UUA. This is an annual report that establishes our official number of members with the UUA; they and other affiliated groups such as SWUUC and NTAUUS use this number to determine the annual dues we are expected to pay as a congregation. This year our membership is 70, up 6 from the 64 members we reported last year. Also, we reported other gains over the past year: average weekly attendance was 57, a gain of 7; amount pledged was \$55,550, a gain of \$5,000; number of pledging units was 43, a gain of 1; religious education enrollment was 26, a gain of 4. Also, I cast our vote in favor of the UUA's current Study Action Issue on Peacemaking, after polling RRUU leaders. These numbers suggest that our congregation is on a path of slow, but steady growth, which at least allows us to have greater confidence in our planning.

Board Actions: (a) The Board has formed a committee (John Ockels, Nell Evans and Viki Reeder) to coordinate our search for a new Director of Religious Education; Viki had requested to serve for only one year in that position. (b) The Board approved a recommendation by Dianna Butler, our Treasurer, that we provide workers compensation insurance for our employees at a total cost of about \$300 per year. The Board also is working with Dianna and the Finance Committee, chaired by Judy Donahue, to revise the duties and procedures of the Treasurer's office. Any amendments to the Bylaws that arise from this will be submitted to the congregation's vote at our May meeting. (c) The Board authorized our Building Committee to upgrade the audio system in the sanctuary. (d) The Committee on Ministry (Elbert Hill, Linda Woytasczyk, and Darrah Dunn) have been asked to establish a system whereby future committee members will be selected for 3-year rotating terms. (e) Roger Gregory-Allen together with Drew Wade and Carla Murphy will be this year's Stewardship Committee, who are scheduled begin the campaign in March.

In the months ahead, we will have our Stewardship Campaign, Budgetary Process and Personnel Contract Renewals, all of which will culminate in our Annual Congregational Meeting in May. In these difficult times, the Board and church leadership will strive to be careful stewards of our church's resources. We welcome any input from the members on this or any other matter. The Board meets on the first Wednesday of every month at 7:15 PM at the Church. Members are welcome to attend.

## January 2009 Treasurer's Report

Happy New Year and Tax Season to All!

This month has been a busy one for me, but I have successfully filed all of RRUU's required payroll tax reports and forms, and we are good with our friends at the IRS for another year.

For January, we had total revenues of \$4,829.88 and our expenses were \$5,631.62, resulting in a net loss of \$801.74 for the month. However, fiscal year-to-date, RRUU is financially holding steady with a net gain of \$218.74. As of January 31, 2009, RRUU has a total of \$53,805.63 in the bank in checking accounts, savings accounts, and CD's.

As of the end of January, we have received \$27,550.00 of our total projected pledges of \$55,550 or about 50%. I have configured my accounting software to track pledges, and I update those pledges on a weekly basis.
