Board Bits ~From the June 14th Board of Trustees meeting

The board meeting was held on June 14th, 2012. All board members except were present except Kat Walston, who was absent do to a change in work schedule. In addition to normal board business the following topics were covered.

- The last two sections of the Policies & Procedures Manual were reviewed. These included Building & Grounds and Worship. After an online vote the entire Policies & Procedures Manual will be posted on our website under Congregational Governance.
- · Kat Walston and Richard Newlin have resigned from the Board of Trustees, effective June 30, 2012. Replacements were appointed at this board meeting. Carolyn Cameron was appointed to replace Kat Walston as Secretary of the Board. Paula Blackshear was appointed to fin-

ish Richard Newlin's term as Trustee At Large.

Adult Forum ~Sunday Mornings

July 1

Adult Forum continues their study of world religions with Buddhism, Hinduism, Ba'hai Faith and Jainism. Information comes from Beliefnet.com and from various internet sources and the format will continue with participants summarizing information and reporting to the group.

July 8

Speaking at Adult Forum this Sunday will be Marion and Elbert Hill. They attended U.U. General Assembly in Phoenix as delegates recently and will share their experiences with the group.

July 15

This will conclude the study of world religions with information from Beliefnet.com and various Internet sources. Participants will summarize and report on the Church of Divine Science, Scientology and Christian Science.

July 22

This will be the first of four lectures on The Theory of Evolution: A History of Controversy, by Edward Larson Ph.D., University of Georgia. There are a total of twelve, 30-minute lectures, and we will break them up into three segments of four each. There will be other topics between the segments and all twelve DVDs will not be shown in twelve weeks.

The first four lectures carry the story through Charles Darwin, who is the single scientist most associated with launching the modern theory of evolution. The DVDs are published by The Teaching Company, a part of The Great Courses.

Lecture number one is titled "Before Darwin" and discussion will follow.

July 29

This will be the second of four lectures from a series on The Theory of Evolution by Edward Larson Ph.D. and is a part of The Great Courses. "Evolution in the Air" is a thirty minute lecture on DVD, and discussion will follow.



Epistle from Elbert

Greetings from General Assembly in Phoenix, AZ! The organizers of this year's General Assembly of the Unitarian Universalist At the 2010 GA, many delegates wanted to vote to boycott Phoenix, which had long been scheduled as the site for the 2012 GA, because Arizona had just passed S.B. 1070, its "Papers, Please" legislation allowing police to stop anyone they suspect of being an undocumented alien and to demand proof the person is in the U.S. legally. But GA congregations in Arizona, led by UUA President Peter Morales, asked that the UUA honor its commitment to come to Phoenix but to use our presence there to make a statement against harsh treatment of immigrants in the state, both documented and undocumented.

Accordingly, many elements of the 2012 convention were different. First, the plenary sessions (where business of the association is conducted)

were fewer and shorter. Then, all of the educational workshops were devoted to justice in some way (immigration, economic injustice, women's issues, racial issues, modern slavery, LGBT issues, people with disabilities, and the legalities that relate to all these). Several sessions discussed the Doctrine of Discovery, which Doug ably covered in his sermon a few weeks ago. Some sessions, especially ones on financial injustice, repeated the same statistics, which became a bit boring but did emphasize important points. Marion and I often had trouble deciding which of several concurrent sessions we would attend, but we usually went to different ones so that we could cover as many as possible.

Events at GA also included three "witness" opportunities during the week, the most important of which was on Saturday evening, when an estimated 2,000 yellow-shirted UUs were bused from the convention center to the infamous Tent City established by Sheriff Arpaio where immigrants unable to produce documentation of their legal status are kept in inhumane conditions. About 100 counter-protesters jeered the UU crowd, but no violence

occurred. The Hills will be back at RRUU on July 8 and will be making a report in Adult Forum about GA.

As your incoming president, I am looking forward to a great new church year, with all of us working together to create an even better religious community than we have been. We owe Marla an enormous amount of thanks for keeping us going the last three years, shepherding us through difficult days, and leading us to our current situation in OUR OWN SPACE, where we are striving to become good neighbors with the community around us and where we feel free to speak out with an independent voice on issues. I personally am counting on help from Marla and from all of you in our continuing endeavors.

Financial Update ~the treasurer's report

The Fiscal Year for 2011-2012 has just ended. How did we do? You be the judge.

Total assets for the fiscal year ending in June 2011 were \$55,483 compared with assets of \$62,156 at the end of June 2012. Since the church building is entered as an asset of \$23,725, the figure of \$62,156 is on the low side. We do have \$47,944 left to pay on the renovation loan and had no such liability last year. However, we also have no rent to pay.

In checking the budget, the figures look good. For total income, \$66,583 was raised compared to the budgeted \$49,893. The majority of the increase of \$16,690 was given for the renovation of the church. Pledges and weekly offerings were also up.

For the most part, expenses were below budget. Administration costs were nearly \$500 below budget; childcare, \$685 below budget; utilities, \$428 below budget and worship costs, \$1796 below budget. RRUU did not meet

its goal for community giving. We were approximately \$950 below what we had hoped to contribute to the community.

Finally, the budget planned for a net loss of \$49,900. At the end of the fiscal year, the books showed a net loss of about \$41,275. This is 82.7% of the expected loss.

Carole Harner will begin her term as treasurer in July, and I am happy to have a pro take charge. At this point in time, I can truly say that I enjoyed the experience and learned more than I ever imagined!
