# 3 Reports

#### 3.1 The Board of Trustees (Marilyn Alexander)

#### Normal duties for the year

- a. Board Rep is assigned each month, and the list of duties is posted on the bulletin board.
- b. Every month we review finances to ensure that we are on track for staying within the budget.
- c. We scheduled and held the Fall Congregational Meeting, Appreciation Dinner, and this Spring Congregational Meeting.

#### Other duties undertaken

- a. Established a Minister Search Team and approved taking funds from savings to go toward the minister compensation fund once we can secure one.
- b. Approved the revised Policy & Procedures Manual and since added policy statements for social media and for statements of conscience.
- c. Approved the new design for nametags.
- d. Held two building cleanup/reorganization days.
- e. Purchased a new printer.
- f. Purchased organization carts for kitchen.
- g. Approved repair of the garages.
- h. Approved chair yoga and "the Power of Now" as new recurring activities.
- i. Reinstituted Conversation and Calories and potluck dinners, following pandemic shutdown.
- j. Opened an eBay account and a PayPal account for Red River, so that purchasers can make donations to Red River.
- k. Authorized, printed, and distributed HELP cards for Texas area and Oklahoma area.
- I. Accepted Dick Powell's resignation as treasurer and appointed Carole Harner as treasurer.
- m. Inventoried items in the garages and sold many items with the funds going to the minister compensation fund.
- n. Reviewed and discussed the UUA "8th Principle" proposal.
- o. Elected Jim Runnels to the nominating committee when Carole Harner had to resign to become treasurer.
- p. Joined Sherman and Denison chambers of commerce.
- q. Approved a Preliminary Budget and target amount for the 2023-2024 Pledge Drive
- r. Approved an ad in the Recycling Guide, which is given to clarify new water customers in Sherman.
- s. Approved \$500 for advertising for the replacement Earth Day Festival that was rained out.
- t. Agreed to put remaining excess funds from the 2023-24 budget into Advertising for public relations.

#### 3.2 Membership Report (Marion Hill)

Five people have joined Red River UU during the past year: Walter and Susie Norris, Jim and Marsha Runnels, and Martina Hernandez. We have frequent in-person visitors to the church, as well as online participation via YouTube and Zoom. People learn about Red River UU through our website, through activities that include game nights, clothing swaps, chair-yoga class, and the Spiritual Self-Help Group/Book Club. The annual Earth Day event in April, organized mainly by Red River UU members, is the church's primary community outreach. The Membership Team met recently and refined procedures for welcoming visitors and new members. Doug Strong and Marion Hill are working on a new brochure titled "Pathway," that details the congregation's Pathway to Membership. Amy Hoffman-Shehan, Adrian Hinman, and others on the team are discussing possible changes to the Time & Talents form that new members are asked to complete. Paula Jennings has volunteered to chair this committee.

#### 3.3 Committee on Ministry (Carolyn Cameron)

"The purpose of the Committee on Ministry is to strengthen and support the congregational health of Red River UU Church by promoting effective ministries in all areas of Red River's mission. Working to uphold the philosophy of shared ministry, the Committee on Ministry seeks to affirm healthy relations between congregation members, between congregation and board as well as between the minister and the congregation." - The Policies and Procedures Manual

The COM meets once a month on the fourth Sunday, immediately after the morning service. There is an announcement in the order of service each month as a reminder. During these meetings we address various areas of Church Life to determine if the congregation's needs are being met. Additionally, during these meetings the COM is also available to individual members who have problems in the congregation. We continue to invite anyone to discuss church issues with us. Committee members are Jim Holmes, Carolyn Cameron, and Elbert Hill.

#### 3.4 Nominations (Jana Norris)

The terms of the following elected trustees and committee members are ending this year. Fortunately, almost all incumbents have expressed a wish to continue in their positions. Marilyn Alexander is stepping down as President. No one has agreed to be nominated in her place. David Dyer is stepping down as Secretary, and Don Rogers has agreed to take his place. David will then assume Don's place as Trustee-at-Large.

#### 3.5 Stewardship Report (Jim Holmes)

A BIG thankyou goes out to all that pledged. We received a total of \$50,310 in pledges for the budget year starting in July 2024. Our target goal was \$47,000 so that put us \$3,310 over our goal. We had 22 pledge units that covered 27 members. We also had 3 friends pledge.

The Finance Team used this excess to cover 2 unexpected increases in two budget line items. The remaining excess was put in the **Communications – Advertising** line item to provide more funds for outreach and social action activity.

This proposed budget was approved by the Board at the April 21 meeting and is presented in the Proposed Budget section of this packet.

#### 3.6 Movable Feast (Marion Hill)

Movable Feast continues to be a popular interest group at RRUU. It meets about once a month for participants to enjoy a restaurant meal, a potluck at the church, a meal in a member's home, or a food-related event. The group includes both church members and friends outside the church. The next planned Feast is a lunch on May 1 at 691, the student-run restaurant at Grayson College. #### 3.7 Minister Search Team (Jim Holmes)

Here is a brief history of activity from July 2023 to current:

In the fall of 2023, we received a grant from NTUUC for \$90,000 to help fund a two-year contract minister. The grant is for \$90,000 to be paid out over 3 years. In addition, we have \$15,000 in pledge commitments toward covering the minister's compensation package. The remainder not to exceed \$51,000 may be pulled from our savings.

The UUA guideline for the minister compensation package is estimated to be around \$185,000 for two years for our GEO code and for a congregation our size.

With enough funding in place, we completed the UUA Minister Application and submitted it in November 2023.

In January 2024, we had one minister show interest in our position. However, when we contacted them, they said they were already in contract negation with another church and declined our position. They did not want to be distracted during their contract negotiation.

In February 2024 we had a second minister show interest in our position. Unfortunately, this minister was looking for a home for the next five years before they retired. They were not interested in only a two-year contract.

There have been no more inquiries into our position through UUA. Our next steps will be to contact some of the Divinity schools and see if there might be interest from some of their students.

We also plan to apply for a Chalice Lighters Grant to help fund our minister. Chalice Lighters will not fund a church that has had a minister, and we had a ¼ time minister for one year in 2009-10. We contacted them to see if this would exclude us and they did not say no but said it would be a consideration. Based on their response, we plan to submit for a grant. They typically do not exceed \$10,000.

Finding a minister may take a while. There are 85 churches on the UUA minister portal that are seeking a contract minister, 18 are in the Southern Region.

The Finance Team also discussed their concerns about the total cost of a minister and the impact on savings. This concern was presented at the April Board meeting.

### 4 Financial Reports as of March 31, 2024

In the month of March, we had total receipts of \$9,606.58. Total expenses for the month were \$4,567.68, leaving us with a net profit for the month of \$5,038.90. The net profit for March was due to the timing of pledge income.

We had a net profit for the fiscal year-to-date of \$7,943.58. The year-to-date net profit was primarily due to the timing of pledge income. We also had higher other income and lower worship expense, partly offset by costs to improve building security and the timing of various other costs.

As of March 31, 2024, we had \$18,003.67 available in checking. There is a total of \$20,752.52 in the bank savings account, including \$4,871.08 restricted for the Minister Fund and \$5,951.89 held in trust for Kat Walston from the sale of her personal effects prior to moving into assisted living. There is a total of \$66,784.40 invested in the UUA Common Endowment Fund. The congregation voted to use up to \$51,000.00 of the Endowment Fund for minister compensation.

After we review how the congregation did on meeting these goals, we will create our new goals for 2024-2025 budget year.

# 8 Considerations on Acquiring a 2-year contract Minister

The Finance Team and the Board of Trustees are concerned about the financial impact of supporting a 2year contract minister. As of Dec. 31, 2023, we had \$59,825 in the UUCEF Red River Savings Fund that is available for use. The congregation voted to spend up to \$51,000 of that on a minister. If we use all of the \$51,000 we would use 85% of our savings and only have \$8,825 remaining. These numbers are approximate since savings funds go up and down based on the stock market. Also, the minister's compensation increases 3% each year so the more time it takes, the more costs grow. The compensation package is the recommended amount by the UUA but does not account for market value should we get into a bidding war with another UU church.

We can't wait for a minister to come along and do all the things we expect of them. It may be that the person we select may not have enough experience in helping us penetrate the Texoma community as we would have hoped. Then, we will have spent all our funds and not be able to hire a minister after the twoyear contract is completed and show little growth or community penetration.

We need to take the necessary steps to become more visible in the community. Instead of putting any excess funds in the minister fund, we should be putting at least some of it in outreach and maybe hire a PR firm to guide us in becoming more visible and effective in the community.
