Bill Nash, *leading* 



The Sherman school district yanked the role from Max, announcing a "new policy" (!) that actors could only appear in roles that matched their biological gender. The enraged—and hurt—family was dumbstruck when not only the citizens of Sherman but of the nation *and the world* stood behind them demanding that the school restore the roles to the students who earned them.

#### AN OPEN INVITATION FROM TXUUJM ...

Social Justice meetings are open to everyone...and we have guest speakers coming you won't want to miss!

May 2, Elle Cross is the Right to Justice Coordinator of Mano Amiga, a nonprofit that organizes alongside immigrants and people harmed by the criminalization to advocate for systemic policy changes in Hays County. The hour will be dedicated to the DeVonte Anderson case. DeVonte has a trial set in June, even though at the trial of his co-defendant, Cyrus Gray, it became clear that "Hays County had poor evidence against [Gray], especially considering the gravity of the charges – no eyewitnesses, video, fingerprints, or DNA connected Gray or Amerson to the murder." Learn about the case and take action to prevent a miscarriage of justice.

Rachel Myslivy, climate Justice Organizer with UUA Side with Love and Rev. Kelly Dignan, Co-Director of UU Ministry for Earth will join us and share more about increasing UUA work with climate Justice. They will invite us into a time of education and reflection about shifting our climate work to include not just the 7th Principle but also our 1st and 8th Principles. It's fun and you're invited! Come every week or pop in when you can. Invite friends, UU or not, Texan, or not. ALL WELCOME.

June 6, special guest Steve Phillips, the New York Times bestselling author, columnist, and political commentator will join us. Mr. Phillips brought his successful tour to UUs For Social Justice in Washington DC. Now, he is focusing on Texas! A BIG thank you goes out to all who pledged. We received a total of \$50,310 in pledges for the 2024-2025 budget year starting July 1<sup>st</sup>. We exceeded our goal of \$47,000 by \$3,310! We had 22 pledge units from 27 members. We also had 3 friends pledge.

We used this excess to cover unexpected increases in the budget line-item Communications - Advertising to provide more funds for outreach and social action activity.

# Hannah Peterson Recipient of 19<sup>th</sup> Amendment Award

Hannah Peterson received a \$500 award from the 19<sup>th</sup> Amendment Committee for a female student from Southeastern University in Durant who has overcome adversity, just as the suffragettes overcame adversity in order for women to get the right to vote. The award was presented at the April meeting of the Bryan County Federation of Democratic Women, a group that contains many members of the 19<sup>th</sup> Amendment Committee that funded the award. She was nominated by Dr. Sondra Petty. Here is a little about Hannah that you may not know.

Throughout school, she was recognized as gifted, but struggled to keep up with assignments. She was different from other students and did not fit into any groups. She rarely had more than one friend, if any. She did not graduate from high school traditionally, but instead received top marks on the GED exam.

Marriage, her first child and economic survival, took its toll until she was hired to work at Apple with the original iPhone launch. That gave her some perspective on her skills and after a few years, on where she wanted to be in life. During this time, she was diagnosed with ADHD, which was a surprise to her. She began learning to cope with her symptoms, but it was a challenge. But then the car was repossessed, and she was unable to get to work reliably. Later, they moved to Arizona for her husband to manage a Dairy Queen and that is when she became a compliance officer at two separate cannabis-growing facilities. She learned a lot about this new industry and was offered a job as a cannabis compliance consultant. She still has that role. While in Arizona, she was officially diagnosed to be on the autism spectrum. From this she learned

more about how her brain works and she is still working on managing the differences in her brain.

She and her family spent 5 months in Vermont attending to the business associated with her mother's death and caring for her dad. They decided that they should combine households and move to Durant, because her husband had family there and he would be able to care for his family while she cared for her father.

Once she got to Durant, she became determined to settle in and find people. First, she found the Red River UU church and began attending with her father in order to help him be more socially active. Then, Marilyn introduced her to the Bryan County Federation of Democratic Women. In the course of her life, Southeastern University kept coming up. She kept meeting people who worked there or had attended classes there. She daydreamed about going back to school. At first, she thought it would be too difficult to return to school, but the more she thought about it, the easier it became in her mind.

Eventually, she decided to return to school full-time. She was very nervous since she was a non-traditional student: she was older, was on the autism spectrum, and she had not succeeded before. This worrying helped her to discover that there was no way that she could do less than her best, because that would be a complete betrayal of this opportunity. She has put everything into her education and has achieved a 4.0 GPA for 5 semesters.

For a while, she felt like she had something to prove, but didn't know who she was trying to prove it to. Then she realized that she was trying to prove it to herself. She needed to show herself that she could achieve her own goals and overcome the obstacles put in her way. She hopes to be an example to others, especially her children, as someone who is focused on achieving her goals despite life's challenges. She wants to show them that they can do it too.

Hannah is a member of Red River UU and serves on the Good Times Team, furnishing refreshments one Sunday per month for Conversation and Calories and she has worked to optimize the website.

Money Matters

In the month of February, we had total receipts of \$1,712.00. Total expenses for the month were \$2,867.63, leaving us with a net loss for the month of (\$1,155.63). The net loss for February was primarily due to the timing of pledge income.

We had a net profit for the fiscal year-to-date of \$2,904.68. The year-to-date net profit was primarily due to higher other income and lower worship expense, partly offset by costs to improve building security and the pm

As of February 29, 2024, we had \$12,967.35 available in checking. There is a total of \$20,749.94 in the bank savings account, including \$4,771.08 restricted for the Minister Fund and \$5,951.89 held in trust for Kat Walston from the sale of her personal effects prior to moving into assisted living. There is a total of \$66,784.40 invested in the UUA Common Endowment Fund. The congregation voted to use up to \$51,000.00 of the Endowment Fund for minister compensation.
